

Reducing Recidivism

Rehabilitation


Family & Community



WHO IS IMPACTED BY REENTRY?

It is a common misconception, that incarceration and reentry only impact the individual directly involved. However, this could not be further from the truth. Reentry impacts justice-involved individuals, their families, and the community. Reentry can also have resounding impacts on our political landscape and economic development. Social service organizations and providers play a crucial role in supporting justice-involved individuals during the reentry process. They offer a range of services, including housing assistance, substance abuse treatment, mental health support, and job training, to facilitate successful reintegration into society. Advocates and activists work to raise awareness of the challenges faced by justice-involved individuals during reentry and advocate for policies and reforms aimed at improving outcomes. They may focus on issues such as access to housing, employment discrimination, and barriers to reentry. Communities as a whole are impacted by Reentry in ways that my not seem as obvious. It's important the individuals are knowledgeable about reentry and are aware of how those efforts can impact those around them as well as their own family, friends and neighbors.





SUPPORTING SUCCESSFUL REENTRY

Supporting successful reentry requires a comprehensive approach that addresses the various challenges faced by justice-involved individuals as they reintegrate into society. Here are some ways to support successful reentry:

Supporting successful reentry looks like removing the stigma that so often follows individuals beyond the bars of jail or prison.

Initiatives like Ban the Box continue to break down barriers that are still in place surrounding affording individuals with justice involved histories access to all of the opportunities for success.



BARRIERS TO SUCCESSFUL REENTRY



BARRIERS

Barriers to successful reentry include and are often intersected by:

- Lack of employment opportunities
- Housing instability & food insecurity
- Limited access to education and training opportunities
- Untreated substance use disorders or mental health diagnosis
- Social stigma
- Collateral consequences
- Family and community support
- Healthcare access
- Legal system policies and practices

CYCLES OF OPPRESSION

Cycles of oppression, especially concerning marginalized and vulnerable communities is critical to address when discussing successful reentry. Before entering the legal system or experiencing incarceration, vulnerable communities are more likely to be exposed to or experience poverty, systematic racism, disruption of family dynamics, health disparities, limited access to resources & opportunities, criminalization of poverty and marginalization, and lack of ability to participate in civic engagement. Once these individuals enter the legal system, these issues are exacerbated due to the added pressures caused by justice-involvement such as stigma and collateral consequences. The very system meant to provide justice only perpetuates further suffering and injustice.

CURRENT EFFORTS & LEGISLATION

In NC, there are several great steps forward being had, but there are still bills that need our support in order to continue opportunities for success for justuce involved individuals. Some of those bills in our state that could use your support are as follows:



- HB 888: Ends the practice of suspending driver's licenses for unpaid fines and fees or missed court dates, removing barriers to employment from court debt.
- \$ 339: Modify limited driving privilege, eliminates the additional 1 year suspension, the additional 2 year suspension, and the permanent suspension for reasons unrelated to public safety.
- S 565: Removing barriers to jobs and housing, reinstates the automated expunction of dismissed and not guilty charges
- HB 778: Prohibition of disclosing booking photographs, restricts law enforcement agencies from knowingly disclosing a copy of pretrial booking photo to a third-party, publish-for payment company.



CURRENT EFFORTS

Reentry 2030: Reentry 2030 is a national initiative that aims to dramatically improve reentry success for people exiting prison & for those under community supervision. As a key part of our mission, NCDAC is committed to helping offenders navigate the complex transition process - and we join our Reentry 2030 partners to work for reentry that is more coordinated, transparent & equitable.

Community efforts, nonprofit programs, second-chance transitional housing, expanded funding opportunities for local reentry councils, and organizations such as Second Chance Alliance are all working together to push these efforts forward.

STEPS FORWARD



BY SIGNING EXECUTIVE ORDER 303, AND OFFICIALLY JOINING THE REENTRY 2030 NATIONAL INITIATIVE, NC HAS SET GOALS FOR MOVING FORWARD, INCLUDING:



VOCATIONAL TRAINING OPPORTUNITIES

Emphasize the expansion and improvement of services around rehabilitation, reentry, and prison education, incliding job skills training and preperation.



MEDICAID ACCESS BEFORE RELEASE

This initiative would ensure all eligible incarcerated individual are offered an opportunity to apply for mediciaid before release.



DRIVER'S LICENSE RESTORATION AND ACCESS

Resources being provided to educate incarcerated individuals on the process of obtaining a driver's license upon release.



HIGH SCHOOL AND POST-SECONDARY EDUCATION

Increase the number of high school and post-secondary credentials earned by individuals who are incarcerated by at least 75%.



HOUSING RESOURCES

Housing resources and support being strengthened to provide stable foundations for those reentering our communities.



LOCAL REENTRY COUNCILS

The further establishment and funding for statewide local reentry councils is a significant step toward providing tailored assistance to justice-involved individuals; connecting individuals with resources, support networks, and opportunities for successful reintegration.



SECOND CHANCE HIRING PARTICIPANTS

Recognizing the pivotal role employment plays in successful reentry, focusing on trying to increase the number of second-chance employer partners by 30%, creating more opportunities for secure meaningful employment.



- The NC Justice Center's Fair Chance Criminal Justice project also hopes to see the SNAP felony ban be lifted and reformed as part of this initiative.
- There is also continued urgency on continuing to pass comprehensive mugshot reform which would protect the reputation of justice-involved individuals.
- Continued engagement with reentry providers and directly impacted community members needs to continue to be build for equitable access to reentry for all.

RESOURCES FOR RE ENTRY

LINC'S REENTRY PROGRAMS

Reentry Programs such as LINC provide critical support for justice-involved individuals. Programs like the **Local Reentry Council**, **Pathway Home**, **Healthy Opportunities Pilot**, **NC Fit and Marvin E. Roberts Transitional Living Campus** work to address critical needs of individuals returning from incarceration by providing a supportive environment and empowering individuals to become productive members of society.

 barriers they create to successful reentry.
- Legal Aid of North Carolina: Legal Aid of North Carolina is a statewide, nonprofit law firm that provides free legal services in civil matters to low-income people in order to ensure equal access to justice and to remove legal barriers to economic opportunity.
 - Second Chance Wilmington: This project provides no cost expunction and driver's license restoration services to individuals residing in New Hanover County. A statewide team also provides these services in Raleigh.


- North Carolina Justice Center: Their mission is to eliminate
